Consignee phone no. is mandatory. Complete and detailed SALE Commerical Invoice, shipper, consignee details, description of value(CIF-FOB-NCV) unit and total value. All products from countries that are not members of the WTO require certificate of origin if FOB value exceeds

USD1000. If sent directly to AR the original certificate of origin will be required if product arrives from other countries the certificate of origin must be stamped by the Consulate of Argentina at origin. - if product arrives from other countries the certificate of origin must be stamped by the Consulate of Argentina at origin. Shipments less than USD800/50kgs do not require preshipment inspection certificate. Used/refurbished products are prohibited as WPX.

- **1.** If product could be "plugged in" it will incur delays and additional costs. "Electric Security Inspection" (Electric machines, electric devices, electric equipment, etc.)
- **2.** Consignee must have import license and will require a National Entity Inspection issued by "ANMAT" and may incur delays and additional costs. For personal use an original prescription is required to release shipment.
- **3.** Consignee must have import license issued by food and drug department. Will require a National Entity Inspection (INAL) and may incur delays and additional costs. Informal entry for personal use, only 2 kgs maximum per product and up to 50 kg and USD3000 per shipment.
- **4.** Fotolithos and film for printing will be revalued per square inch despite their declared value at origin.
- 5. Consignee will have to pay duties and warehouse fees.
- **6.** Spares are held and normal duties will be applied.
- **7.** All textiles must have Certificate of Origin attached to shipment which must be stamped by the Consulate from Argentina located in origin. . Multilated textiles samples require commercial invoice attached to shipment, no certificate of origin is required, maximum 5 pieces for individuals do not require certificate of origin. Up to 10 textiles samples for companies do not require

Certificate of Origin and both can be sent as WPX.

Service Impact Notes

Due to a new regulation from the National Service of Sanitary, the packing wood, support and accommodations, used to transport any merchandise that enters the country should be free of bark, insects and damages. Please check this type of packaging at origin in order to avoid delays/imports additional cost. .

Operation Notes
