Service Impact Notes

No duties/tax exemptions are recognized under courier transport mode. Duties and taxes must be paid prior to delivery. All WPX and formal import shipments require two copies of AWB and Commercial Invoice (no Performa Invoice), besides original attached to the shipment. Personal effects consigned to a private person are converted to a Formal Import (D/A) by Brazilian Customs. It has to be released with a broker. Temporary admission must be sent as WPX formal, otherwise cnee will pay duties/taxes upon arrival.
