Original commercial invoice in USD required. Note following WPX restrictions: Universal postal union restrictions apply for WPX low value. If so , please pre-alert BOG gateway.

1. *If exceeds max quantity of 6 units; Import license required, delay: 3-5 days. This applies to Used and/or repaired spare parts equipment.*
2. *Permit must be previously issued by consignee with ICA (Colombian Agriculture Institute). This also applies to aromatic herbs.*
3. *Technical Description Sheet.*
4. *National institute of food/medicines control certificate.*
5. *Permit must be previously issued by cnee with National Institute of food/Medicine control.*
6. *"Norma Tecnica Colombiana" (Colombian Technical Estandar ) required. This applies to vehicles spare parts.*
7. *Prealert and coordination with country office required.*
8. *Used clothing prohibited unless it is unaccompanied luggage of a recent traveler.*

## Service Impact Notes

Additional duty will apply to all Imports to Colombia, This duty is called "Tasa Especial por los Servicios Aduaneros" (Special Rate for Customs Services) all imports will be subject to a 1.2% tariff or charge for Customs Services over FOB value affecting all Worldwide Parcel Express(WPX) inbound.
