Worldwide Package Express

AWB & invoice must be in US\$ to avoid delay in customs clearance. If Agricultural Products, customs duty exempted, No Commercial Value (N.C.V.). For customs purpose declare only USD100.00 or less. If any shipment exceeds this amount, it will be held for collection of 5% customs duty. Also subject to Ministry approval and pre-alert required. Note following WPX restrictions:
